A bus depot and a café occupy the one-story portion of the building. Transom windows are evident on both the one-story and twostory portions of the building.




Image 2. Existing Condition: The façade of the one-story portion of the Helleberg Building currently is covered with Z-Brick or some other brand of imitation brick facing. A variety of other surface materials have been applied to the building over the years, and discordant signage now further compromises the original architectural integrity of the façade.



Image 3. Retractable Awning: This example installation of a retractable awning—proposed in the design options presented on the following sheets—illustrates its extended position, as well as its typical mounting condition on the building façade (source: www.sunbrella.com).



Image 4. Existing Condition: The original transom windows, with textured glass and original metal storefront window frames, still exists on the two-story portion of the building. Presumably, the same type of transom window still exists beneath the Z-Brick or some other brand of imitation brick facing that was installed on the one-story portion of the building. Underneath the transom window is a protruding lip, below which an original retractable awning presumably was mounted.

Sunbrella Fabric Sample: Logo Red (#4666)

Comments: Options 1.1 through 1.3 depict the use of awnings constructed with the Sunbrella fabric, Logo Red (#4666). The new storefronts and second story windows have bronze-colored metal frames. Option 1.1 shows restoration of the transom windows (with textured or frosted glass similar to the original glass) on the storefronts. Options 1.2 and 1.3 do not necessarily involve restoration of the transom windows. Signage for the stores is appliquéd to the awning valances.




Image 8. Option 2.1: The transom windows on the first floor storefronts are restored, and retractable awnings are installed.

The new storefronts and second story windows have bronze-colored metal frames. Option 2.1 shows restoration of the transom windows (with textured or frosted glass similar to the original glass) on the storefronts. Options 2.2 and 2.3 do not necessarily involve restoration of the transom windows. Signage for the stores is appliquéd to the awning valances.




Image11. Option 3.1: The transom windows on the first floor storefronts are restored, and retractable awnings are installed.

Options 3.2 and 3.3 do not necessarily involve restoration of the transom windows. Signage for the stores is appliquéd to the awning valances.




Image 17. Option 5.1: The transom windows on the first floor storefronts are restored, and retractable awnings are installed.
